DIRECTIVE: EAJR 2021 – 1229

Pursuant to Article XI, section 4 of the Constitution and Bylaws adopted at incorporation and by the authority vested in me as the Right Eminent Grand Commander of the James W. Moss Prince Hall Grand Commandery of Knights Templar, Jurisdiction of Indiana, Prince Hall Affiliated, I, Sir Knight Eugene Anderson Jr., do hereby direct all meetings and ceremonies of all commanderies and guilds subordinate to this Grand Body to continue to be held virtually through June 4, 2022.

In consideration of alarming trends associated with new COVID-19 cases, particularly with Delta and Omicron variants which have been described by the CDC as nearly twice as contagious as the original strains, I issue this directive for the safety of this Grand Body and its membership.

This directive is to be read during stated Commandery and Guild meetings in the months of December, January and February.
